TERMS OF MEMBERSHIP AND PRIVILEGES OF MEMBERS

Membership of Dairy Technology Society of India is open to all individuals who are engaged in the pursuit of Dairying in the Country and abroad.

1. Categories of Organizational Membership

- A. Benefactor Member** – Any institution paying a lumpsum of Rs.25,000/- can become a Benefactor of the Society for a period of 10 years. A Benefactor Organization will have all rights and privileges of an Ordinary Member and shall be eligible to nominate one person as its representative to attend Annual General Body Meetings of the Society.
- B. Sustaining Member** – Any institution contributing a sum of Rs.10,000/- annually can become Sustaining Member of the Society. A Sustaining Member/Organization will have all rights and privileges of an Ordinary Member and shall be eligible to nominate one person as its representative to attend Annual General Body Meetings of the Society.

2. Categories of Individual Membership

- A. Ordinary Member:** A person willing to be enrolled as a new Member has to pay an annual subscription of Rs. 300/- only. The annual subscription of a Member shall become due on the 1st April of each year. An Ordinary Member will have the right to be present and to vote at all meetings of the society, to propose candidates and to stand for any elected office of the society, to contribute papers at meetings of the society, and to receive free of charge the Journal of the Society which are not specially priced, as decided by the CEC.
- B. Life Member:** A person interested in the activities of the Society who pays a lumpsum fee of Rs.1000/- could become Life Member of the Society. A Life Member will have all the rights and privileges of an Ordinary Member. The Life Membership Fee for Foreign Members is 200 US\$.
- C. Student Member:** A person who is a student of bachelor's degree or post-graduate in Dairy Technology & allied sciences can become a Student Member. The annual membership fee for a calendar year will be Rs.200/- only. Post-graduate students of Dairy Technology and allied sciences can also become Life Members. A Student Member will be entitled to be present at meetings of the association like a Life Member or Ordinary Member and will be entitled to receive the Journal of the Society. He/She will not be eligible to vote or to stand for elected office.

Mode of Payment of Membership Fee
